

EDITORIAL POLICY
of the journal
“Vestnik of the Moscow State Linguistic University. Social Sciences”

The journal is published four times a year, has an international standard serial number (ISSN) 2500-347X and is included in the database of the Russian Science Citation Index (RSCI). Since June 2016 the journal has been published as an online publication and is freely available on the official website (http://www.vestnik-mslu.ru/vestnik.asp?vest_lang=Rus&vest_type=obn) and on the platform of the Scientific Electronic Library (www.elibrary.ru).

The journal is included in the list of peer-reviewed scientific journals in which the main scientific results of PhD and Doctor’s thesis should be published.

The edition is addressed to employees and students of educational and scientific organizations, researchers and specialists interested in studying sociology, political science and history. The journal's work is based on the principles of originality, reliability, validity and verifiability of the provisions set forth in the publications.

The journal publishes articles on the following scientific specializations:

Manuscripts are accepted for consideration:

- No. 1 – until January 20;
- No. 2 – until March 10;
- No. 3 – until June 10;
- No. 4 – until October 10.

The specified period may be shortened or extended in certain cases decided by the editorial board, depending on the fullness of the sections, as well as in conjunction with the prepress preparation. When submitting a manuscript, the

editorial board recommends that authors specify the researcher's identifiers (ORCID, Scopus). Only one article of the author can be published in one issue of the journal.

After receipt by e-mail of the editorial office (vestnik.social@linguanet.ru) the manuscript:

- is considered for compliance with the above-mentioned scientific specializations;

- in case of compliance, it is checked for originality;

- if the requirements for originality are met, it is sent for review, by the results of which a decision on the possibility of publication is made.

The manuscript undergoes a double-blind review. In case of conflicting reviews, the decision on additional review or on the possibility of publication is made by the editor-in-chief.

The editorial board notifies the author about the results of work with the manuscript.

The editorial board agrees with the position of the Higher Attestation Commission under the Ministry of Education and Science of the Russian Federation on the need to *"consider any attempts to pass off the results of scientific research obtained by other scientists as their own, including through the use of the institute of co-authorship,"* and reserves the right to verify the validity of self-citation, and in the case of co-authorship – to clarify the author's contribution.
